Employee is observed not wearing a face covering indoors or in public spaces where social distancing cannot be maintained	Ask if employee is aware of the university face covering mandate. If employee does not have a face covering, direct them to the locations designated by the college or department where they may obtain a face covering. If employee indicates a medical concern with wearing a face covering, advise the person that they need to request an exemption from Human Resources but must wear a face covering in the interim. Employee fails to comply with directive to wear face covering, maintain social distancing, or directive to remain off campus due to positive results or close contact	If an employee refuses to wear a face covering without a proper medical exemption approved by Human Resources, or if employee refuses to comply with social distancing, report the behavior to the supervisor. Corrective measures may begin with additional training and informal coaching. Employee may be subject to formal corrective/disciplinary action if they engage in behavior that is a serious health and/or safety concern, such as failure to wear a face covering, maintain social distancing, or returning to campus without clearance. Student is observed not wearing a face covering indoors or in public spaces where social distancing cannot be maintained	Ask if student is aware of the university's face covering mandate. Bystanders are encouraged to have an educational discussion to remind students that wearing of face coverings is considered an additional public health safety measure to help reduce community transmission of respiratory diseases and COVID-19. If student does not have a face covering, direct them to the nearest location to obtain one. If student indicates a medical issue with wearing a face covering, advise them to contact the Office of Accessibility Services (OAS) and that they must wear a face covering in the interim. If student refuses to comply, make the report including the directive issued by the reporting individual on behalf of the University. Instructor Guidance for Students in Classroom

Student is not wearing a face covering or maintaining social distancing during class	Communicating clear guidelines at the start of each term will aid in setting the tone in the classroom. The Instructor should post the mandate on face coverings and social distancing on Canvas and post reminders in the classroom if class is face-to-face. If a student is not wearing a face covering or adhering to social distancing in class, the Instructor should remind the student of the mandate and ask the student to comply. If student indicates a medical issue with wearing a face covering, ask them to show authorization from the Office of Accessibility Services (OAS) or to contact OAS if they have not done so. Student fails to comply with directive to wear face covering or maintain social distancing during class	Instructors may ask that students leave class immediately when they do not comply with directives and their behavior is disrupting the learning process. Instructors should remind students that behavior that does not meet standards can subject them to charges under the Student Conduct Code. Instructors who have concerns about disruptive student behavior should report that concerning behavior at report.fsu.edu. Student fails to comply with directives for face coverings and social distancing and refuses to leave class after directed to do so	If a student refuses to leave a class after being directed to do so by the Instructor, the Instructor may end class in order to deescalate the situation. The faculty member should notify the appropriate administrator and submit a report at report.fsu.edu. Student behavior becomes disruptive and poses a risk to the Instructor's safety or the safety of students.	After ending the class, if the student's behavior poses a risk to the Instructor's safety or the safety of that student or other students, FSUPD may be notified for assistance.
